### Fire Safety Committee Olivia Diaz

At the April 16 organizing meeting, the new Board of Directors decided to break the Roads and Environment Committee into two. The new Fire Safety Committee will focus primarily on issues having to do with the safety of Cascade Shores residents during a wild fire.

While there is some natural overlap, the Roads and Environment Committee will focus mainly on road issues-getting permission to use the road over Scotts Flat Lake Dam, urging the County to improve Pasquale Road into a two-lane emergency egress and looking at other alternative emergency exits from Cascade Shores. Roads and Environment will continue to deal with the perennial issues of truck traffic, dust and signs.

Vice President Harry Wander chairs the Roads and Environment committee. His committee consists of Harold

Barber, Bill Carter, Carol Carter and Jim Kain.

The Fire Safety Committee consisting of me, Kain, Barber, Carters, Curt Sutliff and Wander, will focus on working with Tim Fike, Consolidated Fire Chief, on developing a Fire Safe Plan. Tom Coburn and Tim Fike have given us material for an action plan, which will provide the basis for our development and written plan. New roads are long-term projects and fire season is coming right up. The committee is focusing its attention on developing in-place shelter(s). Ideally these would be available before summers end.

Many thanks to the Cascade Shores committee members who have been working on making something happen in time to be of use to any residents who suddenly might need a safe haven.

### Salute to the Quiet Heroes of Cascade Shores Jim Kain

We were down to one; now there are three volunteer 49<sup>er</sup> Fire Protection District firefighters living here in Cascade Shores.

Scott Parsons, a veteran of 20 years service, is a Captain in the Sacramento Metropolitan Fire Department during the day and when he is off shift, he volunteers for the 49<sup>er</sup> FPD. Scott lives on Pawnee Trail with his wife Carol, mother Annie, and three teen-aged children. Son of a Nevada City firefighter, Scott learned firefighting starting at

Ron Breeden lives with his wife Joanne on Pasquale Road. He supervises a unit of Parole and Community Services, California Department of Corrections in Marysville.

Perri, wife Cozette, and two young sons, live on Quaker Hill Road. Perri is a native of Grass Valley while Cozette hails from Colfax. Perri is a former American Airlines pilot and is now a loan consultant for Sun Pointe Mortgage Services operating from his home.

### Lost Mine Lake Rental Fee Increase Heather Linderfelt

Due to the increase in insurance premiums on Lost Mine Lake, the board decided to raise the fee for renting the facilities at the lake. As of June 9<sup>th</sup>, the cost of renting the facilities for a member of the CSHA will rise to \$75, and for non-members, the cost will rise to \$100. We are hoping this will make up for the increase in insurance and help us keep the lake as a nice perk for members of CSHA.

### I'm Sorry Lady You Can't Water Your Plants!! Jim Kain

Or words to that effect, were uttered by the NID worker to a Cascade Shores resident watering her garden on a hot July day in 1985. There was a restriction against outside watering by agreement between NID and CSHA. The lady took it up with CSHA and that's when the fit hit the shan! Heavy Fourth of July weekend usage that year almost drained the two water storage tanks dry. When NID acquired the water system from the developer in 1969 there was a written agreement between CSHA and NID that no outside watering would be allowed. Limited capacity of the water treatment plant and storage tanks couldn't accommodate it. After all, Cascade Shores was developed as a summer resort, not for permanent homes with gardens.

CSHA had, indeed, signed the 1969 agreement restricting water use to inside dwellings. Furthermore, property owners would pay the expense if any improvements to the water system were to be made Even further, the monthly fixed rate of \$3 per month was to be raised to \$8 and owners would pay any future rate adjustments. Eventually rates/usage was measured by meters.

The "sale" (actually handover) of the water system by the developer/property owner took place at a property owners association meeting in San Jose, California in 1969. The association rule then was that each property owner had one vote. Since the developer still owned most of the properties, his majority vote swung the deal.

When word got out about what happened tempers flared and at a meeting in Cascade Shores demanded by people who had bought property, they called in a Deputy Sheriff to keep order. The handover prevailed, peace returned and the "no outside watering" rule was not enforced by NID unless water usage began to threaten capacity.

Your writer was asked by the homeowner's board to form a committee to "negotiate" the matter with NID. The first thing we did was meet with the then general manager, Jim Chatigny. We reached an agreement not to "negotiate" but to form an agency/property owner committee to work out a solution. A committee was assembled, representing all property owners, including summer users, and vacant lot owners. Chief engineer Bob Singleton headed up the NID contingent. An engineering study made by NID in 1984 concluded that unrestricted use would produce problems for the water treatment plant by 1990. The study proposed two basic approaches to the problem. The one adopted was to upgrade the water system by collecting money from all property owners as well as providing dis-

trict funds to make the improvements.

Over several months we arrived at the following: Total cost of a new treatment plant and two new tanks was estimated at \$445,000. Homeowners were to pay \$276,000 and the district \$168,000. Homeowners could pay their individual portion by lump sum or over several years with their monthly bill.


The committee was able to reduce costs to the property owners by determining that some segments of the project were replacement items (like replacing the old tanks) and could be charged to maintenance rather than capital construction. A clause stipulated that cost under runs would be kept by NID and overruns would be paid by NID.

An announcement from NID dated February 7, 2003 brings an end to the saga of the threatened water restriction. The announcement told us our water would be turned off on February 19 to tie-in a new storage tank, the last of two tanks for our system pledged by NID in 1986. This tank was to be installed on Summit Ridge, the final segment of improvements previously agreed upon.



In retrospect the property owners got a very good deal. Federal and State pure water upgrade requirements and NID elected improvements have kept our water system in line with state-of-the-art treatment plants. From the start of improvements resulting from our agreement reached in 1986, NID has spent almost a million dollars on our system. AND WE ARE GUARANTEED A CONTINUOUS SUPPLY OF OUR WONDERFUL, PURE MOUNTAIN WATER.

### Free Brush Chipping Program Tim Hagan, CDF/FEMA Field Coordinator

With the arrival of spring also comes the renewal of the California Department of Forestry & Fire Protection's free brush-chipping program. Lucas Weed Control of Fresno is the new contractor and on Tuesday May 13 they started working on this winter's backlog of brush. Lucas is a thoroughly professional outfit and has hired and trained a crew of local workers.

We will have 2 crews providing the chipping service this summer so don't be bashful about trimming out the fire ladder fuels or spacing out the distances between tree crowns. One crew will continue working through December.

As in the past, the chipper will be in Cascade Shores, Deer Creek Park and along Pasquale Road the first full 5-day week of each month. If the brush cannot be seen from your road, i.e., it's up the driveway, please call 265-2678 and leave your address on the answering machine. If the crew can see the brush from the road there is no need for a phone call, they will chip it and leave you the mulch.


Remember to stack the brush with all the cut ends facing in the same direction, in a location where the truck and chipper can easily and safely get to and away from. We will chip up to 8-inch diameter material, but <u>no</u> scotchbroom, blackberries, poison oak, root balls, or dirty material that will damage the machine.

The late season spring rains have given the forest plenty of energy for regrowth. Please use the free chipping program to maintain your fire safe zones. If you have any questions about the program or where to stack the brush I'll gladly make an appointment with you to go over things.

Your efforts and cooperation in making Cascade Shores a more fire safe community is greatly appreciated by the fire fighters from both CDF and the 49er Fire Protection District.

### Cleaner Sewage: At what price?

It's a question that has surprising urgency for communities throughout the state. New Federal and State wastewater disposal regulations adopted in 2000 have made it a lot more challenging to comply with new water quality standards. Regulations require every stream and river in the state to be treated as if it could be used for swimming, drinking and fishing.

Currently 104 property owners in the Cascade Shores area are within the County Sanitation zone that administers the wastewater disposal. In 1996 a new wastewater treatment plant was constructed to meet the Federal and State requirements. In June 2001 the State issued new requirements for the Cascade Shores plant to be complied with by June 2006.

County staff has been working hard to find cost effective ways to meet the requirements. Last year the County was pursuing land disposal of the effluent on the 20-acre parcel where the treatment plant is located. This turned out to be unfeasible because of the high ground water levels present on most of the site.

Currently homeowners pay \$910 per year to operate and maintain the plant. Current estimates are that the annual fee will need to be increased to approximately \$1400 to cover current increased operation and maintenance costs. To investigate ways to meet the new permit requirements annual fees may need to be further increased.

County staff met with Regional Water Quality Control Board (RWQCB) staff on May 22, 2003 to discuss what could be done to find an economically acceptable solution to the problem. The RWQCB staff responded that they were very concerned about the problem and wanted to fully cooperate with and assist the County, where possible, to find a solution.

Property owners will receive a notice of an upcoming meeting, tentatively scheduled for June 23, to discuss the current situation and necessary next steps toward solving the problem.

This is a critical issue which is being faced by many other wastewater districts throughout the state. Water quality is unquestionably important. It will be up to the property owners working with the County and State to find the most cost effective way of meeting the new requirements.



Peter Van Zant, Nevada County Board Supervisor for District 1 comments: "The county is very concerned about the new requirements and the severe effect they could have on rate payers. I am extremely supportive of any projects that could offer a creative and economically attractive solution. Meanwhile, County staff will continue to work with the RWQCB to seek ways to minimize the impact to Cascade Shores residents."



### **Cascade Shores Women's Club**



Their arrival date seemed too early this year, but the continual snow and rain mix did not seem to dampen the homeowners' spirit in renovations. Currently, the smaller male guards the nest while the female, who in the beginning fished with the male, sits on 2-4 buffy, brown-blotched eggs.
